

### FIRST STEP CONTRACT BONDS UP TO \$500,000

RLI's First Step program is designed for straight-forward construction projects with completion dates of a year or less. Credit and reference checks may be required. Valued contractor customers with solid credit and a good reputation will be considered for bonded aggregates up to \$500,000.

#### Prequalification Letter submissions should include:

- 1.) Completed First Step Application
- 2.) Any specific job information, if Owner and/or Job Specific

#### Bid Bond submissions should include:

- 1.) Completed First Step Application
- 2.) Copy of the bid invitations/specifications
- 3.) Any required bond forms

#### Performance & Payment Bond or Supply Bond submissions should include:

- 1.) Completed First Step Application
- 2.) Copies of the bid results
- 3.) Contract agreement
- 4.) Any required bond forms

Upon bond acceptance, a General Indemnity Agreement will be emailed to all required parties for electronic signature.

RLI's First Step program does not apply to subdivision/completion, service, residential, design-build, software, maintenance, multi-year or environmental contracts, with the exception of asbestos and lead based paint removal/abatement. This is subject to change and may not be all-inclusive.
